Deadline to submit a completed application which has been accepted by Ofsted is approaching for existing providers of supported accommodation



In light of the recent growth of supported accommodation provider applications to register with Ofsted, we are now moving confidently towards the 28th of October deadline and the NCB are continuing to share the range of helpful resources that been informed by conversations with 100+ local authorities and 900+ providers who have engaged with the Sector Awareness and Provider Preparedness programme.

Based on Ofsted registration guidance, this resource is designed to enable supported accommodation providers and local authority practitioners to understand the registration process from start to finish.

Our eLearning courses have been completed by 500+ people so far and are still available to complete and they are designed to improve confidence and develop knowledge relating to the regulations, Quality Standards and the registration process.

Roles and Responsibilities
