# NCB's Regional Community of Practice Events Networking, information-sharing, and working collaboratively



Throughout June and July, the National Children's Bureau is running a series of Regional Community of Practice events for local authorities and supported accommodation providers.

The aim of our Regional Community of Practice events is to provide a space for networking and shared learning with local authority or provider colleagues. They are also an opportunity to discuss challenges, needs and support requirements for the new regime.

Attendees from the East Midlands, East of England, North-West, South-East, London, Yorkshire & Humber, North-East and South-West have joined our events in a variety of locations so far, with one more session to go:

• West Midlands (Wednesday 12th July)

Our morning sessions have been attended by a variety of local authorities from each region, with supported accommodation providers coming together for our sessions in the afternoon.

Attendees heard from the NCB who shared feedback from their baseline survey and the national conferences that took place at the end of April, as well as information about upcoming support as part of the Sector Awareness and Provider Preparedness Programme.

Using an Action Learning approach to guide discussion, those who have attended the Community of Practice events shared the challenges and barriers they are facing in relation to the new Regulations and quality standards.

After discussing this with the wider group, attendees worked collaboratively to identify solutions and actions to address challenges

and move plans forward.

Some of the key themes from discussions in the Community of Practice events so far are:

#### Local authority sessions

- Quality assurance
- Parallel planning and sufficiency
- Local authorities registering as supported accommodation providers

#### **Provider sessions**

- Staffing and recruitment
- Ofsted inspection framework
- Multi-agency working
- Supported lodgings and how the new regulations will affect this area

At the end of the afternoon session, providers had the opportunity to ask specific questions about registration and the regime in a virtual session, attended by Ofsted representatives.

Some feedback we have received from the events so far:

In September, NCB will be running follow-up Community of Practice sessions. These will be held virtually and will bring together both local authorities and supported accommodation providers in one event to facilitate further collaborative problem solving.
